## **REQUEST FOR DRIVING PRIVILEGES**

# You are not guaranteed occupational driving privileges just because you ask.

When the Judge suspends your driving privileges, he usually has the option of granting you driving privileges. However, there are times when Ohio law dictates if or how soon he may grant such privileges. In addition, the Judge has his own rules about when and for what circumstances he will grant driving privileges. You are not expected to know the law or the Judge's rules concerning these requirements. You may apply for privileges whenever and for whatever reason you wish. Your request will be reviewed and privileges will be granted according to Ohio law and the Court's rules. Always, the Judge has the option of denying such requests and often does so if Defendants are not in compliance with the law, his orders, or Ohio Bureau of Motor Vehicles (BMV) requirements. The probation officer does not grant or deny privileges. He only reviews your sentence, checks Ohio BMV records, and completes the paperwork for the Judge's signature.

The following is a check list of all things considered before granting privileges:

- □ You have an otherwise valid operator's license with no other suspensions of any kind. This means an unexpired license with no other court suspension in this court or any other court; no 12-point or noncompliance (insurance) suspension, security suspensions, or FRA suspension (unless proof of SR 22 bond is on file here and at the BMV) or any other suspensions by the BMV.
- □ You were covered by insurance at the time of the violation and you are covered now. Proof of such insurance coverage must be on file with the court and the Ohio BMV, if required.
- □ If you were ordered to do so, you have turned in the license plates to ALL motor vehicles that you own, including plates you still have for vehicles you have sold or otherwise disposed.
- □ You have purchased "family" tags per RC 4507.164, if so required and you have shown proof of having such license plates by filing a copy of the registration certificate in the clerk's office.
- □ You have paid all fines and costs in full.
- **u** You have show proof of employment or school.
- □ If you are not a high school graduate, you have shown GED certificate or proof that you are currently enrolled in classes.
- **U** You are in compliance with all court orders and terms of probation.
